Non-Aligned Movement supports Nicaragua on ICJ ruling

Nicaragua received the support of the Non-Aligned Movement (NAM) regarding its right to demand that the United States comply with the ruling issued by the International Court of Justice, to compensate the people of Nicaragua for damages caused throughout its history, informed Vice President Compañera Rosario Murillo.

"This morning the Ministerial Meeting of the Non-Aligned countries was concluded in Azerbaijan. During the final session this morning, we once again received support for Nicaragua, in our right to claim compensation from the United States, in keeping with the historic judgment of the International Court of Justice, which ordered them to indemnify Nicaragua for all the damages caused throughout history, particularly during the 80's, and the damages that still continue, the damages that they continue to cause us with all their aggressions", she said. She affirmed that, "there we received support, regarding our demand for reparation, justice and restitution, indemnifying our Nicaragua for the damages, for the harm, and for the catastrophic consequences of [its] wars against Nicaragua".

The Non-Aligned Movement (NAM) once again expressed its support of Nicaragua's efforts to ensure that the United States comply with the Judgment of the International Court of Justice.

Today, Thursday, 6 July 2023, in its final session the NAM Ministerial Meeting reaffirmed its defense, respect for international law, the sovereignty of States and Peace. It recalled the support expressed at the Eighth NAM Summit in paragraph 229, in Harare, Zimbabwe, 1986, in the case of Nicaragua versus the United States, supporting Nicaragua's request to demand compliance with the final and binding judgment issued by the International Court of Justice that the United States indemnify and compensate Nicaragua in accordance with the judicial ruling of 27 June 1986.

Accompanied by a diplomatic delegation from the Embassy of the Bolivarian Republic of Venezuela in Nicaragua, headed by Ambassador José Francisco Javier Arrué de Pablo and members of the university community, Dr. Alexander Torres Iriarte, Director of the National History Center of this Venezuela delivered an online lecture "The Independence of Venezuela".

This activity, organized by the Miguel d' Escoto Brockmann House of Sovereignty, was inaugurated by the Vice Rector General and Acting Rector Dr. Luis Alfredo Lobato Blanco, who noted that this activity takes place within the framework to commemorate the 212 years of independence of Venezuela, whose struggle radiated to all the oppressed peoples of that time.

During his speech, Dr. Torres emphasized that every representation of the past is an expression of a historiographic political project, since history is an instrument of battle that contributes to the understanding and transformation of social reality. In this sense, he mentioned that even in our time there are texts that spread cultural colonialism and the concept of "discovery". However, at the same time, there exists counterpart that promotes multicentrism, its pluricentrism and multiculturalism. "There is a history that is science, but it is also awareness of the dialogue between the past and present, where it is necessary to understand these times in order to [better] understand the past," he said.

About the Independence of Venezuela, he pointed out that there are some successes, as well as pending tasks. He also emphasized that all peoples are called upon to understand their history, with its nuances and peculiarities, which have an indelible colonial heritage, marked by the constant aggressions, initially, of the Spanish and Portuguese crowns in their eagerness to appropriate for themselves our country's resources.

XXVI Meeting of the Sao Paulo Forum. 29 June to 2 July

RESOLUTION OF SUPPORT TO THE DEMAND OF NICARAGUA FOR COMPLIANCE WITH THE JUDGMENT OF THE HAGUE IN FAVOR OF NICARAGUA.

From the SAO PAULO FORUM we support the initiatives to demand fair compensation before international tribunals for the different damages caused by climate change and other illicit acts throughout history, including slavery.

Similarly, we recall that there is a historical debt with the Nicaraguan people that 37 years later has not been settled by the United States. It is an obligation clearly established in the final judgment of 27 June 1986 by the highest international judicial authority, the International Court of Justice, which issued a sentence condemning the United States of America to compensate Nicaragua for all damages caused as a result of its military and paramilitary activities against Nicaragua. Although the Court recognized that in a situation of armed aggression such as that carried out by the United States, no type of reparation - neither economic nor moral - could compensate for the devastation of the country, the loss of human lives and the physical and psychological wounds of the Nicaraguan people, the Court decided that the United States had a legal obligation to make economic reparations to Nicaragua for all the damages caused.
